When completing your Free Application for Federal Student Aid (FAFSA) use the Federal School Code **008815**. Students in the Dental Hygiene Program attend classes during the summer. Since the summer is part of the full academic year, it is considered an extra semester. Eligibility for financial aid during this term may be limited if a student has used most or all of their aid during the fall and spring semesters. If a student does not wish to use all aid offered to them during the fall and spring semesters, they are able to reduce their aid online, thus leaving them aid for the summer.
